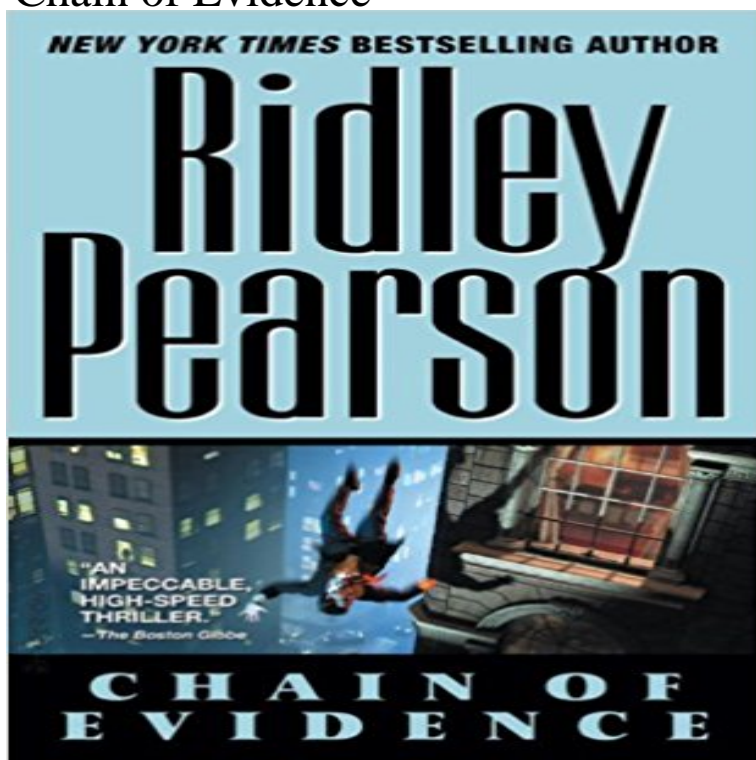


Chain of Evidence
