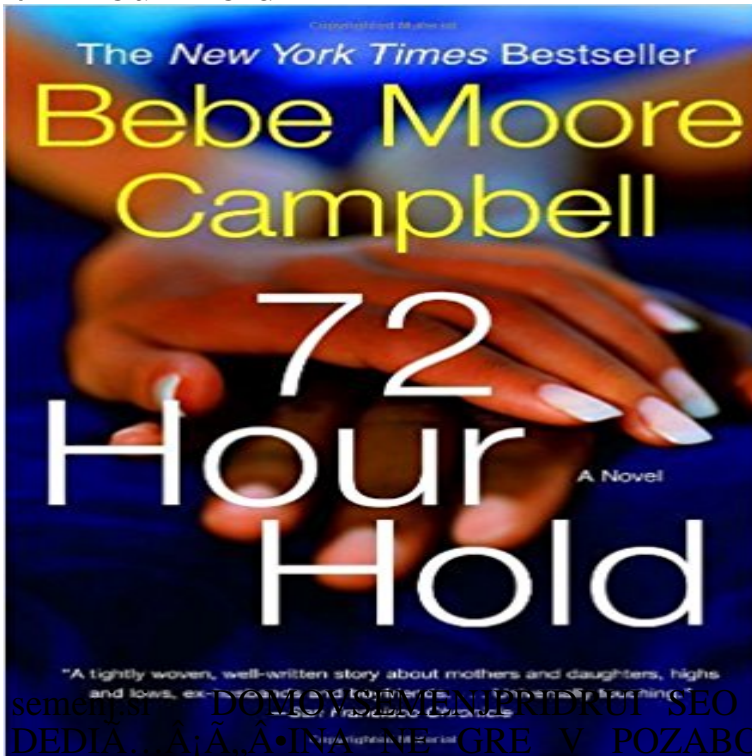


72 Hour Hold
