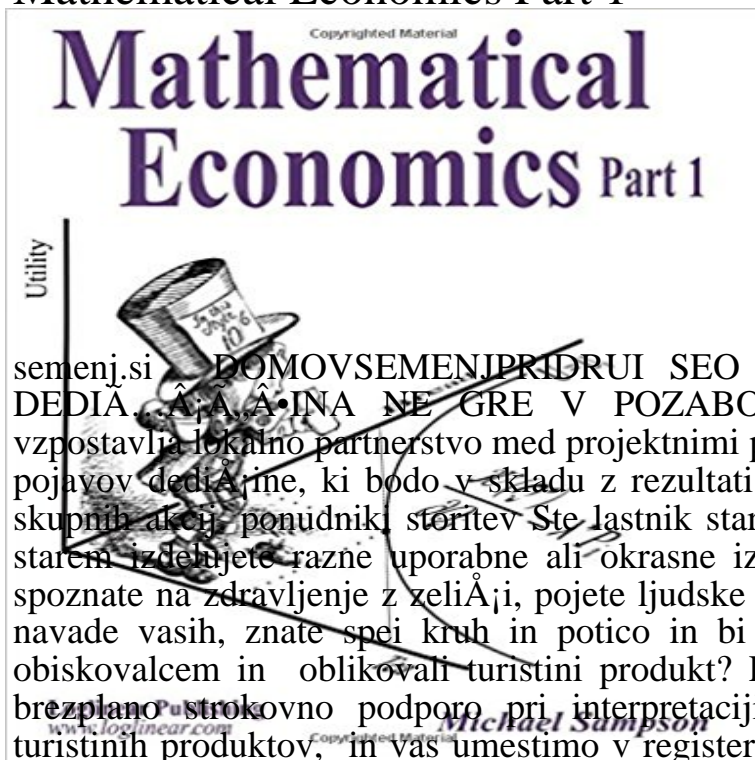


## Mathematical Economics Part 1
